## RESEARCH SCHOLARSHIP

### Call for applications – 1 (one) vacancy

The Centre for Social Studies (CES) – Associate Laboratory - University of Coimbra (Portugal), opens a call for applications for 1 research scholarship (CES/03/2026-BI-SAFEBOT) in the project SAFEBOT - SUPPORTING ADOLESCENTS' FEELINGS & EMOTIONS THROUGH A CHATBOT FOR A WHOLE-SCHOOL APPROACH TO STUDENTS' EMOTIONAL EDUCATION AND WELL-BEING (2025-1-ES01-KA220-SCH-000357214), funded by the Spanish National Agency (SEPIE) in relation to the project funded by the Erasmus+ Programme, coordinated at CES by the Principal Investigator Tatiana Moura.

CES provides a stimulating intellectual environment in social sciences and humanities. The project is part of the research line Europe and the Global South: Heritages and Dialogues, which includes researchers interested in analysing the articulations between Europe and the Global South, at various scales, in the framework of an increasingly multipolar world marked by colonial legacies that shape multiple forms of violence. #### a. Project Description:

SAFEBOT - SUPPORTING ADOLESCENTS' FEELINGS & EMOTIONS THROUGH A CHATBOT FOR A WHOLE-SCHOOL APPROACH TO STUDENTS' EMOTIONAL EDUCATION AND WELL-BEING

The SAFEBOT project aims to promote students' well-being and support teachers in creating emotionally safe, inclusive and digitally competent school environments, through a whole-school approach to socio-emotional education, embedding well-being into the school's culture, policies and everyday practices. Throughout the project, three key resources will be developed: Pedagogical Toolkit for Teachers; SafeBot chatbot; Students' Library.

The project also seeks to promote the responsible use of technology and strengthen digital literacy, supporting students and teachers in developing the critical skills needed to navigate the digital environment and identify misinformation related to emotional and mental well-being. In summary, this initiative aims to enhance students' social, emotional and relational competences, support teachers with innovative, inclusive and accessible methodologies, and contribute to the creation of school environments where everyone feels supported, heard and empowered to thrive within the school community and beyond.

Expected duration of project execution: 24 months, starting November 1, 2025.

#### b. Scientific field:

Social and Human Sciences – Sociology, Education, Pedagogy

#### c. Work plan, tasks:

The selected applicant is expected to have the following responsibilities:

i) Carry out literature review, and write the state;

- ii) Carry out quantitative field research with education professionals and families on gender and mental health;
- iii) Collaborate in methodologies development and training for gender-transformative interventions;
- iv) Collaborate in the writing of policy briefs;
- v) Support in the writing of project reports and publications;
- vi) Support the tasks related to project management, namely organising team meetings, workshops and training activities.

#### **d. Applicable Legislation and Regulations:**

#### **e. Workplace:**

The tasks will be performed at the Centre for Social Studies facilities in Coimbra, or in other locations when necessary for the good implementation of the work plan, under the scientific supervision of the Project's Principal Investigator, Tatiana Moura.

#### **f. Duration of the fellowship contract:**

The fellowship will last 12 months, starting in February/March 2026. The fellowship contract may be extended for equal or different periods until the end of the project, depending on the evaluation of the work carried out, the project's financial provisions, and scientific needs.

#### **g. Application dates:**

Opens on: 23 January 2026

Closes on: 6 February 2026

#### **h. Application process:**

Applications must include:

- a) a letter of intent/motivation in English with the contest reference (CES/03/2026-BI-SAFEBOT), e-mail and phone number;
- b) detailed Curriculum Vitae;
- c) copies of degree certificates; (note: candidates must meet the eligibility conditions and conditions indicated in point k.)

d) copy of the enrolment in a non-academic degree, but integrated into the pedagogical project of a higher education institution (note: candidates must meet the eligibility conditions) and conditions indicated in point k.).

Applications should be sent by e-mail to [concursos@ces.uc.pt](mailto:concursos@ces.uc.pt) until the final deadline and will be valid only after a reading receipt is sent. Applications must include a clear indication of the reference of this call (CES/03/2026-BI-SAFEBOT *NAME OF APPLICANT*).

## SKILLS/ QUALIFICATIONS

### i. Preferred selection criteria and their weighing:

Applicants must demonstrate expertise on the topic of the project by fulfilling the following criteria:

1. Motivation letter explaining how the scientific track of the applicant relates to the SAFEBOT project (30%);
2. Previous research experience in similar projects (20%);
3. Experience or documented knowledge of qualitative research methodologies (20%);
4. Knowledge of gendered analysis (10%);
5. Proficiency in Portuguese and English (20%).

The jury reserves the right not to select any candidate.

## BENEFITS

### j. Monthly Allowance

The monthly stipend is 1259,64 euros according with the Regulations for Fellowships at the Centre for Social Studies and at FCT ([https://www.fct.pt/wp-content/uploads/2025/02/Tabela\\_valores\\_SMM\\_2025.pdf](https://www.fct.pt/wp-content/uploads/2025/02/Tabela_valores_SMM_2025.pdf)). The payment of the Voluntary Social Insurance and the Personal Accident Insurance adds up to this amount.

## ELIGIBILITY CRITERIA

### k. Mandatory requirements

1. Be a PhD student in the year 2025/2026 or have a master's degree and be enrolled in a course that does not confer an academic degree but is part of the educational project of a higher education institution (see associated conditions in a);
2. Hold a master's degree in the area of Social Sciences and/or Humanities – preference to Education and pedagogy (see associated conditions in b);
  - a) Applicants must provide proof of enrolment in a PhD or non-academic degree course, in the current academic year. If at the time of application, the applicant does not have a valid document proving

their enrolment, they must send a declaration of honour in which they state to undertake the enrolment within a maximum period of 30 days after the communication of the results, under penalty of not contracting the scholarship.

b) Applicants with an academic degree and diploma issued by a foreign Higher Education Institution must present proof of recognition of the academic degree by the Portuguese Higher Education System, (law DL66/2018). Any candidate without the recognition of the degree(s) will be admitted to the competition, but during the evaluation process the selection panel, cannot:

- i) recognise the candidate's grades and assess according to the possession of such grades;
- ii) give equivalence to, or validate, the grade of her/his degree;
- iii) use that note or its conversion as an evaluation parameter.

In case of selection, the fellowship contract can only be signed after the recognition of the academic degree by the Portuguese authorities, under the terms of the Law-decree n66/2018, August 16. The selected candidate must deliver the recognition of the degree within 30 days after the communication of the results. After 30 days, the jury may decide to 1. either extend the deadline for the candidate to prove the recognition; 2. assign the fellowship to the second place; 3. or not award the fellowship.

## SELECTION PROCESS

### I. Selection process

Applicants will be selected based on their curricular evaluation. In case of equivalent curricular evaluations, the best-positioned applicants should be short-listed for an interview, meant to assess the applicant's potential in integrating the project's scientific dynamic and his/her motivation in pursuing studies related to the project's thematic areas. Each of the two methods of selection applied will have a rating of 50% in the final classification.

### n. Communication of Results:
